

**ORDINANCE NO. 947**

**AN ORDINANCE AMENDING THE CODE OF THE CITY OF EDWARDSVILLE, KANSAS (“CODE”), APPENDIX A FEE SCHEDULE AND REPEALING ALL OTHER ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT WITH THE PROVISIONS OF THIS ORDINANCE.**

**WHEREAS**, the City levies fees and charges for various municipal services; and

**WHEREAS**, such fees and charges are reviewed and amended from time to time to ensure the fees and charges are appropriate to cover expenses related to such municipal services.

**NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF EDWARDSVILLE, KANSAS:**

Section 1. Appendix A Fee Schedule of the Code of Ordinances, City of Edwardsville, Kansas is hereby amended by adding the following:

**Police Department Document Fees**

Accident Reports

Attorney - \$15  
Individual involved in accident - \$5  
Insurance Company - \$15

Kansas State Offense Report (KSOR)

Attorneys under Discovery - \$15  
Insurance Company - \$15  
Victim living in Edwardsville - Fee waived  
Victim not living in Edwardsville - \$5

CD/DVD Media

Attorneys under Discovery - \$15

Fingerprinting

Walk in requests - \$5 per card  
Court order - \$10 per card (added to court fines)

## **Fire Department Document Fees**

### Fire or EMS Reports

Victim/Patient living in Edwardsville - Fee waived  
Victim/Patient not living in Edwardsville - \$5  
Attorney - \$15  
Insurance Company - \$15

## **Animal Related Fees**

Impoundment – Administrative Fee: \$25 per impounded animal  
Impoundment – Daily Fee: Actual Cost  
Vaccinations – Actual Cost

## **Community Center**

### Sunday through Thursday (8am – 10pm)

Rental Fee	\$25.00 per hour, minimum 2 hours
Deposit	\$75.00
Additional key deposit	\$25.00
Security Officer Fee	Alcohol is prohibited for weekday rental

### Friday and Saturday (8 am – 12am)

Rental Fee	\$250.00 Edwardsville Residents \$500.00 Non-Residents
Deposit	\$500.00
Additional key deposit	\$25.00

### Security Officer Fee (Required if serving alcohol)

\$25.00 per hour, minimum 2 hours up to 150 people  
\$50.00 per hour, minimum 2 hours over 150 people


Section 2. All other ordinances or parts of ordinances in conflict with the provisions of this ordinance shall be and are hereby repealed.
