

ORDINANCE NO. 1014

AN ORDINANCE AMENDING THE CODE OF THE CITY OF EDWARDSVILLE, KANSAS (“CODE”), APPENDIX A - FEE SCHEDULE AND REPEALING ALL OTHER ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT WITH THE PROVISIONS OF THIS ORDINANCE.

WHEREAS, the City levies fees and charges for various municipal services; and

WHEREAS, such fees and charges are reviewed and amended from time to time to ensure the fees and charges are appropriate to cover expenses related to such municipal services.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF EDWARDSVILLE, KANSAS:

Section 1. Article A8.000 Utility Related Fees is hereby amended to read as follows:

Sec. A8.001 Solid waste

(a) Service charge: \$17.50 per month.

(b) Delinquent fee: \$5.00 per billing cycle.

Cross reference—Sections 13.02.042 and 13.02.043.

Sec. A8.002 Sewers

(a) Service Charge

(1) Residential:

a. Monthly base rate: \$24.95

b. Variable rate: \$3.75 per CCF

(2) Commercial:

a. Monthly base rate: \$28.95

b. Variable rate: \$4.32 per CCF

Section 2. Section A9.004 Community Center shall be amended to read as follows:

Sec. A9.004 Community Center

(a) Sunday through Thursday (8:00 a.m. – 10:00 p.m.)

Rental fee	\$25.00 per hour, minimum 2 hours
Deposit	\$75.00
Additional key deposit	\$25.00
Security Officer fee	Alcohol is prohibited for weekday rental

(b) Friday and Saturday (8:00 a.m. – 12:00 a.m.):

Rental fee	\$250.00 residents; \$500.00 nonresidents
Deposit	\$500.00
Additional key deposit	\$25.00

(c) Security officer fee (required if serving alcohol):


Up to 150 people	\$35.00 per hour, minimum 2 hours
Over 150 people	\$70.00 per hour, minimum 2 hours

Section 3. All other ordinances or parts of ordinances in conflict with the provisions of this ordinance shall be and are hereby repealed.

Section 4. This Ordinance shall take effect and be in force from and after its passage and publication as required by law.


